 This Deed of Declaration of Trust executed at on this 31st day of May 2012 by **G.VEEMARAJ (ID PAN CARD: AADPV8554D)** S/o.Gumarandi Reddy (Late), **Telugu Origin**, aged about 65 years residing at No.3362-AQ, Block-AF, 8th Street, 11th Main Road, Anna Nagar, Chennai - 600 040 hereinafter called as Founder and **AUTHOR OF THE TRUST AND;**

Whereas it is necessary and desirable to declare and constitute the said Trust and to record the objects and constitution of the said Trust.

Whereas the **AUTHOR OF THE TRUST** decided to create and establish a Trust for Educational and Charitable Purposes such as providing Education, Medical Aid Socio - Economic development etc. for the Welfare of the community at large without discrimination of caste, creed etc, with objects and constitution as hereinafter set forth.

NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH AS FOLLOWS:

Whereas the said objects in view, the **AUTHOR OF THE TRUST** has decided to endow the said TRUST a nucleus of Rs.1,000/- (Rupees One Thousand Only) in cash and

- TRUSTEES:** mean and include the Board of Trustees as described in these presents, and these Trustees, as appointed, nominated or selected whenever any vacant arises.
- CREATION OF THE TRUST:** In pursuance of the intention, the **AUTHOR OF THE TRUST** has settled the sum of Rs.1,000/- by cash unto and in favour of the Trustees herein to be held by them for and on behalf of the Trust hereby created and known as **"SRI AMBAL EDUCATIONAL AND CHARITABLE TRUST"** the receipt of which sum of Rs.1,000/- which has already been handed over to the Trustees mentioned hereunder, is hereby

acknowledged by the Trustees, who hereby accept the appointment as such Trustees of the said Trust under the terms and conditions, set out hereunder for the fulfillment of the objects of the Trust, more fully and particularly described and set out hereunder.

- REGISTERED OFFICE OF THE TRUST:** The registered office of the Trust is situated at present at **Plot No.44, Ambal Nagar, Vilathikulam, Tuticorin District.**
- Trustees : The **AUTHOR OF THE TRUST** hereby affirm that the board of trustees shall be constituted to start with the following members to hold the office of the Trust as life trustees:
 - Mr.G.VEEMARAJ** (ID PAN CARD AADPV8554D) S/o.Gumarandi Reddy (Late), **Telugu Origin**, aged about 65 years residing at No.3362AQ, Block-AF, 8th Street, 11th Main Road, Anna Nagar, Chennai - 600 040 will be the trustee and will hold office for lifetime or until he resigns.
 - Mrs.MAHESWARI RAJ** (ID PAN CARD AADPV8555C) W/o.G.Veemara, **Telugu Origin**, aged about 62 years residing at No.3362AQ, Block-AF, 8th Street, 11th Main Road, Anna Nagar, Chennai - 600 040 will be the trustee and will hold office for lifetime or until she resigns, the next trustee chosen from her legal heirs.
 - Mr.S.K.SUBBA REDDIAR** (ID PAN CARD AHFPS 5710J) S/o.Kasthuri Reddiar, **Telugu Origin**, aged about 47 years, residing at No.99, Keelakarandai Kamatchi Chettair Street, Aruppukottai, will be trustee and will hold office for lifetime or until he resigns, the next trustee chosen from his legal heir.
 - Mr.SR.SHRINIVAS** (ID FAMILY CARD 26/W/0014683) S/o.Late.Raju Reddiar, **Telugu Origin**, aged about 40 years, residing at No.183C, Thillai Nagar, By-Pass Road, Sattur, will be the trustee and will hold office for lifetime or until he resigns, the next trustee chosen from his legal heir.

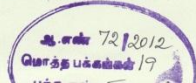
- Mr.G.V.MARKANDAYAN** (ID : PAN CARD BTDPM8268H) S/o.G.Varadarajan, **Telugu Origin**, aged about 36 years, residing at Ramachandrapuram Village, Vilathikulam Taluk, Tuticorin District, will be the trustee and will hold office for lifetime or until he resigns, the next trustee chosen from his legal heir.
- All the above life trustees who will hold office for life and the co-opted trustees to be appointed by the life trustees from time to time shall constitute and be referred collectively as **BOARD OF TRUSTEES** .
- The total number of trustees shall not exceed nine and shall not be less than Five.
- The co-opted trustees can be nominated by the life trustees by two third majority and they will hold office for three years.
- OBJECTIVE OF THE TRUST:** The object of the Trust is providing Education, Medical - aid, socio -economic welfare etc, to the community.
 - To establish educational institutions for imparting general, technical, vocational, professional, industrial and other kinds of education and training and if need be to conduct work shops and other interactions for the utility and welfare of the general public.

The Educational Institute shall retain the legal status of the College/ Educational Institutions/Trust as a Telugu Minority institution and shall continue to avail the benefits under the relevant rules.
- To provide and maintain boarding homes, hostels, etc, for the students studying in the said educational institutions, besides encouraging higher educations, post-graduate studies and over-seas studies.
- To maintain study centres for imparting general knowledge and guidance and to make them fit to appear for competitive examinations without charging any fees / free of Cost.

4. To make pecuniary grants by way of scholarships, donations or allowance for the existing educational institutions and for individual benefits of students and scholars.
5. To promote and inculcate the dignity of labour and mankind, the appreciation of Intellectual gifts and talents of all kinds.
6. To supply books, dresses and other paraphernalia incidentals to the provision of educational facilities to the students.
7. To develop healthy attitude towards the Development of Mental, Physical and moral upliftment of the students and scholars and all those connected with the educational institutions of all kinds.
8. To establish, conduct and maintain Hospitals, Clinics, Dispensaries, Maternity Homes and other Institutions for affording Medical Treatment, care, rest, recuperation and other relief to the General Public.
9. To engage in other constructive national services by establishing and maintaining Institutions, study centers, old age homes, orphanages and welfare projects for children, women and weaker sections of the society.
10. To conduct orientation programs for teachers and social workers in order to improve the quality of education and for improving the socio-economic conditions of the sections of the society.
11. To create environmental awareness among the people and to impart environment education to them.
12. To do all such other acts, deeds and things as may be necessary, incidental, conducive or convenient to the attainment of the above said objects and not involving the carrying on any activity of profit.
13. The above objects shall be independent of each other. For any reason whatsoever, the Trust shall be valid and operative with respect to the above objects and the Trust may apply from time to time, the funds and properties of the Trust in carrying out all or any of the valid objects of the Trust, as it may, in its absolute discretion, deem fit.

5.3 **BENEFIT OF THE TRUST:** The beneficiaries of the trust and activities of the trust shall be limited to the territory of India, irrespective of Caste, religion, race, sex etc.

6. **THE PROPERTIES OF THE TRUST:** The properties of the Trust shall be
 - a) The said sum of Rs.1000/- above referred to the receipt of which is hereby acknowledged by the trustees.
 - b) Any properties movable or immovable, that may be acquired by the Trust either by purchase, lease or otherwise
 - c) All additions and acceptations to the Trust fund
 - d) All voluntary donations both towards corpus or otherwise gifts, legacies or grants in cash or in kind accepted by the trustees.
 - e) All grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies, etc, and
 - f) All sums and assets which by and means become the property of the Trust.

7. **QUALIFICATION OF THE TRUSTEES:**

1. No person of unsound mind or convicted of an offence involving moral turpitude, adjudged insolvent, suffering from physical infirmity which render unfit for active work, in the opinion of Co-Trustees after due enquiry, found guilty of gross negligence or dereliction of duty and found disqualified to act as the Trustee according to law for the time being in force governing the Trust, shall hold office or continue to hold office or be appointed as a Trustee.
2. The trustee must be an individual and no corporate body be appointed as trustee of this Board of trustees.

8. **CESSATION OF TRUSTEESHIP:**

The Appointed / Co-opted The trustees shall cease to be the trustee of the Trust if:-

- a) he resigns
- b) he becomes insolvent
- c) he is removed by the majority of the members of the trust if it is found that the trustee(s) activities are detrimental to the activities or administration or funds of the trust.

9. **APPOINTMENT OF TRUSTEES:**

Any vacancy in the board of trustees shall be filled up by the majority decision of the life trustees.

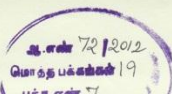
10. The administration of the Trust shall vest with the Board of trustees which consists of all the life trustees and the co-opted trustees. At present the Trust Board will consist of the following office bearers.
1. G.VEEMARAJ – as president or Managing Trustee who will hold office for 5 years.
2. Mrs.MAHESWARI RAJ, as Vice President who will hold office for 5 years.
3. SR.SHRINIVAS – as Secretary who will hold office for 5 years.
4. S.K.SUBBA REDDIAR – A Treasurer who will hold office for 5 years.

The Post of President, Vice President, Secretary, and Treasurer will always be held by the life trustees.

11. **POWER OF THE TRUSTEES:**

The Board of trustees shall have the control and management of the trust and exercise the following powers.

To determine from time to time to commence and to take up the object and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit.

To purchase and acquire any immovable property of any kind.

To take on lease any property.

To sell, mortgage, or dispose of any immovable property / properties belonging to the trust.

To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust.

To sell, lease, mortgage or dispose of any property, immovable property / properties belonging to the trust.

To enter into any agreement with Govt-Central or State or with local bodies or with Banks / Financial Institution in pursuance of the objects of the trust.

To donate in cash or kind to all causes of similar objects and charitable purposes by reason of their locality or operation of otherwise.

To receive endowments for any specific purposes to achieve the objects of the trust and administer them separately.

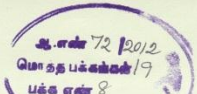
To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bank accounts.

To borrow for and on behalf of the trust with or without security from banks, Governments, Universities or any other government Body / bodies both central and state, to employ staff of all kinds necessary and useful for carrying out the objects of the trust

To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust.

To purchase, take on lease, give on lease, amalgamate, Absorb and / or take over any educational institution and administer it efficiently.

To receive money by way of donations, presents, gifts from the public and grants and subsidies from the Govt. in cash or in kind of properties, movable or immovable for the object of the trust.

To receive acquire and improve properties of all kinds, lands and buildings, erect buildings or conveniences necessary or convenient for the purpose of any of the objects of the trust.

To institute, conduct, defend, compound, withdraw, compromise, adjust and refer to arbitration or to do such things as are incidental and necessary concerning the affairs of the Trust and to sign and verify vakalath, letter of litigation, pleadings, affidavits and other powers.

To delegate all or any of the powers vested in the Trustees to any body' to frame rules, by laws and other codes for the conduct of the affairs of the Trust and its transactions.

To establish as may ad-hoc committee for any purpose.

To accept contributions in cash or in kind either by way of addition to the trust fund generally or for any one or more of the specified objects of the trust.

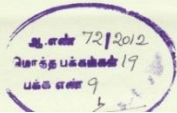
To appoint any qualified person for the eligible post that that arises in the trust or organization formed by the Trust.

To remove, demise, retrench or to take any disciplinary proceeding on any of the appointed persons working in the trust or any organization formed by the trust.

12. POWER OF THE MANAGING TRUSTEE:

The Managing Trustee will be Executive Officer of the Board of Trustees and as such he will have power and authority, for and on behalf of the Board of Trustees.

- I. To carryout the resolutions
- II. To sign papers, receipts and documents
- III To pay money due by the Trust and demand / get receipts therefore
- IV. To demand and receive money due to the Trust and issue receipt therefore

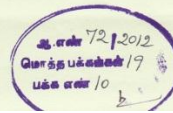
- V. To open current and / or savings and /or call deposit/ fixed deposit accounts in the name of the Trust with such Bank(s) as they may from time to time determine, authorize, in this behalf or deposit the funds of the Trust in such accounts and to operate on such accounts on behalf of the Trust.
- VI. To make, draw and use, accept, sign, negotiate or transfer cheques, promissory notes, hundies, bill of exchange, bill or lading, railway receipts, warranty and other negotiable or transferable instruments, Govt. securities or other securities.
- VII. To lease out lands and properties of the trust which are ordinarily leased out or to get on lease lands / properties for the benefit of the Trust.
- VIII To initiate, prosecute, defend, compromise, refer to arbitration or abandon legal proceedings or disputes and to appoint associates for the said purpose.
- IX. To execute all documents on behalf of the Board of Trustees.
- X. Generally to do all other acts and things necessary or incidental to the proper day-to-day management of the institutions and establishments maintained and / or conducted by the Trust.
- XI. To shoulder the entire responsibility for all the assets as well as the liabilities of the Trust.

13. MEETINGS OF THE TRUSTEES:

The Managing Trustee shall preside over all the meetings of the trustees and in his absence the secretary of the Trust shall preside such meeting and in the absence of both, the trustees attended such meeting may elect any one of them to preside over the meeting.

The meetings of the Trustees may be convened by the Managing Trustee or under his direction by any other Trustees.

The quorum of the meeting of the Trustees shall be four personally present.

Any meeting of the Trustees without serving prior notice to all life trustees is absolutely barred and can not pass any resolutions to take any decision.

Any meeting of the trustees can not be convened without the presence of atleast one life trustee.

In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

14. RESOLUTIONS :

The Trustees may exercise all the powers vested in them in clause 11 under these presents by resolution passed at a simple majority of the trustees attended such meetings of the Board of Trustees.

Any resolutions in writing signed by all Trustees holding office for the time being shall be valid and binding.

15. SUITS :

The Managing Trustee of the Trust is authorized to sue or to be sued on behalf of the Trust.

16. EXECUTION OF DOCUMENTS:

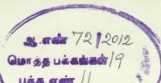
All Deeds, Documents etc shall be executed by the Managing Trustee and or the secretary of the trust.

17. ACCOUNTS AND AUDIT:

The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.

The year of account shall be the financial year commencing from 1st April and ending 31st March.

The Trustees shall each year issue a report setting Out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.

The accounts of the Trust shall be audited every year by a Chartered Account who may be appointed for the purpose by the Board of Trustees and the audited statement of accounts together with Auditor's report shall be laid before the Board of Trustees for approval.

18. BANK ACCOUNT :

The Managing Trustee or his authorized representative will operate bank account(s).

19. POWER TO ALTER RULES AND REGULATIONS:

The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. The Amendment shall be intimated to the Director of Income Tax exemption within the stipulated time.

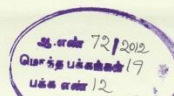
20. APPLICATION OF INCOME AND TRUST FUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments, shall be in accordance with the provision of Section 13 (1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

To receive any contribution, donations or helps from any private person or persons or body of a Foreign nation as per the provisions under F.C.R.A Act (Foreign Contribution Regulation Act)

21. REMUNERATION TO THE TRUSTEES:

The Trustees are not entitled for any remuneration. But they shall however be entitled to receive out of pocket expenses incurred by them in the course of discharging the functions of the trust. Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way of profits, interest, dividend or otherwise.

22. INDEMNITY :

Every Trustees shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

23. IRREVOCABILITY

The Trust is irrevocable

24. DISSOLUTION :

On dissolution of the Trust, the net assets of the Trust shall be transferred to an association of persons or Trust or society having similar objects of this Trust enjoying exemption under section 11 & 80 of the Income Tax Act and such other provision incorporated under Income Tax Act or code.

Not more than 5% of the Trust fund would be applied for religious purposes or given to religions institutions.

25. PROCEEDING OF THE TRUST

Any defect in the constitution of the Trust shall not invalidate its proceedings.

26. RESIDUARY :

For matters not provided for in these presents, the provisions of the Indian Trust Act and the Income Tax Act 1961 and rules made there under will apply accordingly.

No immovable or movable property in the name of the Trust as on date except this corpus amount of Rs.1000/-

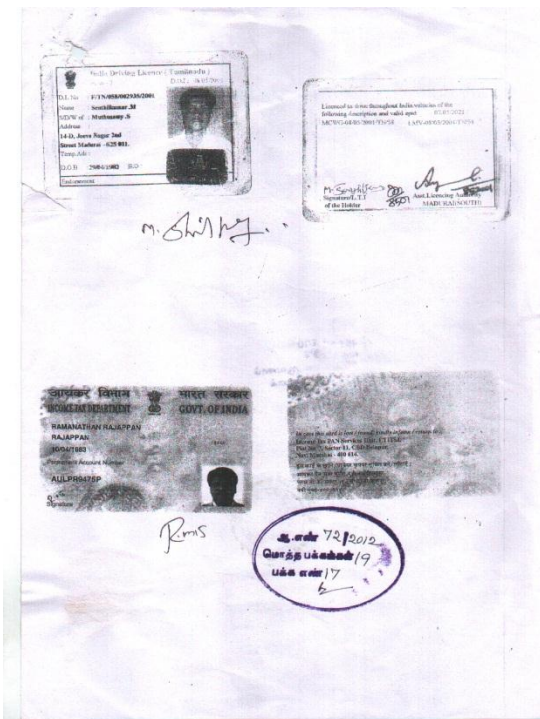
